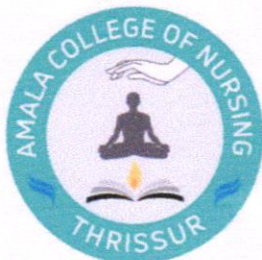

Norms and guidelines for research ethics and public guidelines

We believe that ethical publishing leads to a better science community, where ever and everyone is responsible for the work they do.

Norms for research ethics

1. Declare to your chosen journal that your manuscript is not published elsewhere
2. Declare any conflicts of interest
3. Check all co-authors meet criteria for authorship and ensure appropriate acknowledgements made in the manuscript
4. Include appropriate funding statements in the manuscript
5. Show informed consent and provide assurances that participants' rights are p
6. Register clinical trials*
7. Be alert to bias and follow guidelines for accurate and complete reporting of a
8. Inform the journal if you subsequently find errors in your research
9. Sign a copyright agreement
10. Get ethical clearance from institutional ethical committee
11. Respective heads of the departments must see the content prior submission c article.

Guidelines for research ethics

Guidelines provide resources and practical advice on ethical concerns that arise in academic publishing for authors, researchers, editors, and other audiences.

Ethical standards for publication exist to ensure high-quality scientific publications, in scientific findings, and that people receive credit for their work and ideas.

Article Assessment

All manuscripts are subject to peer review and are expected to meet standards of excellence.

Plagiarism


Authors must not use the words, figures, or ideas of others without attribution. A be cited at the point they are used, and reuse of wording must be limited and be quoted in the text.

Duplicate Submission and Redundant Publication

If authors have used their own previously published work, or work that is current as the basis for a submitted manuscript, they must cite the previous articles and in their submitted manuscript differs from their previous work.

Redundant publication, the inappropriate division of study outcomes into more the (also known as salami slicing), may result in rejection or a request to merge submission of manuscripts, and the correction of published articles.

Fabrication and Falsification

The authors of submitted manuscripts or published articles that are found to have falsified the results, including the manipulation of images, may incur sanctions, articles may be retracted.

Authorship and Acknowledgements

All listed authors must have made a significant scientific contribution to the research manuscript, approved its claims, and agreed to be an author. It is important to list made a significant scientific contribution. Changes in authorship must be declared and agreed to by all authors. Anyone who contributed to the research or manuscript preparation, but is not an author, should be acknowledged with their permission.

Conflicts of Interest

Conflicts of interest occur when issues outside research could be reasonably perceived to affect the neutrality or objectivity of the work or its assessment. In most cases, this declaration will not stop work from being published nor will it always prevent someone from being involved in a review process.

Conflicts include the following

Financial funding and other payments, goods and services received or expected by the authors relating to the subject of the work or from an organization with an interest in the outcome of the work.

Affiliations being employed by, on the advisory board for, or a member of an organization with an interest in the outcome of the work


Intellectual property- patents or trademarks owned by someone or their organization

Personal-friends, family, relationships, and other close personal connections

Ideology -beliefs or activism, for example, political or religious, relevant to the work

Academic- competitors or someone whose work is critiqued

References: If you refer an external source in your paper, you should cite where you found that source. Give credit to the actual contributor, they deserve this.

Authors Short Profile: Short bio of all the authors, include a small picture also. People should know you too!

Each Author (s) Short Profile with Photo(s)

Title: Title must be informative and specific. It should be easily understandable by reader and should reflect motive of the research paper

Author Name, Affiliation and Email ID: Author First name and Last name only. Please don't include salutations like Dr/Mr/Prof etc. If possible provide only your professional email id, instead of personal.

Abstract: One paragraph containing at most 100 words. It is a summary of the report describing the question investigated, the methods used, the principle results and conclusions

Keywords: Five most important terms that describe your research domain and specific problem area investigated.

Introduction: It is a brief section usually not more than a page. It should be informing the reader of the relevance of your research.


Literature Survey: This section includes a short history or relevant background of the research area being addressed.

Methods/Approach: This section should describe how you are supposed to rectify the problem, what approach or what methodology you are supposed to use in your paper

Results/Discussion: This section describes the outputs generated in the methodology section. Elaborate and compare your results with previous research performed in the past

Conclusion: Final extract of your research performed. Concisely elaborate your final output here

1. Initial review submission form (new addition- sample will be issued from ethics committee office).
2. Alignment –Font size 12, Spacing 1.15, Times New Roman Format. Protocol must have page number.
3. Title with name, designation, address and contact number of Investigator, Guide and Co Guide
4. Background / need/ significance of research project
5. Objectives
6. Research methodology in detail (setting, sample size, inclusion and exclusion criterion, Procedures and Statistical analysis)
7. Budget and advertisement details, if any
8. References, at least six in number
9. Format of information to participants in English, Malayalam and in participants' languages
10. Format of informed consent of participants in English, Malayalam and participants' Languages

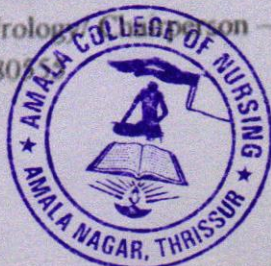
Sample formats of 9 and 10 should be in the format available from EC office.
